TRANSFER RULES

Seller's Responsibilities:

Date of the sale is the date that the animal changes ownership. It is the responsibility of the owner(s) to complete the PDR transfer in its entirety and submit it along with the original Certified of Registration to the PDR Office with the proper fees to be transferred into the new owner(s) name. There will be a \$25.00 penalty fee to any PDR member who gives the application for Transfer or Certificate of Registration to the buyer.

Refusal or Neglect to Transfer:

In case of willful refusal or neglect of the seller to give a transfer without reason satisfactory to PDR, the record of change of ownership maybe made by the Secretary on satisfactory evidence of sale and delivery.

Auction/Sale Barn Consignment:

Sellers are to give the Auction/Sale Barn the Certificate of Registration and Transfer, with seller's part filled in a signed before the Auction. The Auction/Sale Barn will then take the transfer fee out of the seller's commission and mail the Certificate of Registration with the completed Transfer with new owners name filled in along with the transfer fee to the PDR Office.
